3 SECTION 1. SHORT TITLE.
4 This Act may be cited as the "Barriers to Suicide

5 Act of 2019".

1 SEC. 2. GRANT PROGRAM.

- 9 gram, the Secretary may make grants on a competitive
- 10 basis in accordance with this section.
- 11 (c) Eligible Recipients.—The Secretary may

- 14 (d) APPLICATIONS.—To be eligible for a grant under
- 15 the Program, an entity described in subsection (c) shall
- 16 submit to the Secretary an application in such form, at

- 18 retary determines appropriate.
- 19 (e) Eligible Projects.—The Secretary may make
- 20 a grant under the Program only for a project that facili-
- 21 tates the installation on a bridge of—
- 22 (1) a suicide prevention net;
- 23 (2) a suicide prevention barrier; or
- 24 (3) any other evidence-based suicide deterrent
- 25 that is determined by the Secretary to be appro-
- priate.

(f) Priority.—In making a grant under the Pro-1 gram, the Secretary shall give priority to a project located in an area with a high rate of suicide or other priority 4 characteristics, as determined by the Secretary. 5 (g) FEDERAL SHARE.—The Federal share of the cost 6 of a project assisted with a grant under the Program may 7 not exceed 80 percent. 8 (h) DEFINITIONS.—In this section: 9 (1) STATE.—The term "State" means each 10 State of the United States, the District of Columbia, 11 each commonwealth, territory, or possession of the 12 United States, and each federally recognized Indian 13 Tribe. 14 (2) Evidence-based suicide deterrent.— The term "evidence-based suicide deterrent" means 15 a suicide deterrent that demonstrates a rationale 16 17 based on high-quality research findings or positive 18 evaluation that such deterrent is likely to reduce or 19 prevent suicide, and includes ongoing efforts to ex-20 amine the effects of such deterrent. 21 (i) AUTHORIZATION OF APPROPRIATIONS.—There is 22 authorized to be appropriated to carry out the Program 23 \$10,000,000 for each of fiscal years 2020 through 2024.
