1	SEC. 2. REQUIREMENT TO CREDIBLY REPORT HATE
2	CRIMES.
3	Section 505 of the Omnibus Crime Control and Safe
4	Streets Act of 1968 (34 U.S.C. 10156) is amended by
5	adding at the end the following:
6	"(j) Evaluation for Reporting on Hate
7	CRIMES.—Beginning not later than three years after the
8	date of the enactment of this Act and from the data ac-
9	quired by the Attorney General in accordance with the
10	Hate Crimes Statistics Act (34 U.S.C. 41305), the Attor-
11	ney General shall establish a method of evaluating and use
12	such method to evaluate whether a covered jurisdiction
13	has credibly reporting hate crimes, including whether, for
14	each year, a covered jurisdiction—
15	"(1) has not reported hate crime data to the
16	Federal Bureau of Investigation; or
17	"(2) has reported zero hate crime incidents to
18	the Federal Bureau of Investigation.
19	"(k) Eligibility.—
20	"(1) In general.—A covered jurisdiction that
21	is found not to have credibly reported hate crimes
22	following an evaluation pursuant to subsection (j)
23	shall not be eligible for an allocation under this sec-
24	tion.
25	"(2) Exception.—A covered jurisdiction that
26	is found not to have credibly reported hate crimes

1	following an evaluation pursuant to subsection (j)
2	shall not be subject to a penalty under paragraph
3	(1) if the Attorney General certifies that the covered
4	jurisdiction has conducted significant community
5	hate crime public education and awareness initia-
6	tives.
7	"(l) Annual Report.—Each year the Attorney Gen-
8	eral shall publish on the internet website of the Depart-
9	ment of Justice a report on the covered jurisdictions cer-
10	tified under subsection (k)(2).
11	"(m) Significant Community Hate Crime Pub-
12	LIC EDUCATION AND AWARENESS INITIATIVES.—The
13	term 'significant community hate crime public education
14	and awareness initiatives' means that a covered jurisdic-
15	tion—
16	"(1) has—
17	"(A) made substantial progress towards
18	comprehensive reporting hate crimes;
19	"(B) adopted a policy on identifying, inves-
20	tigating, and reporting hate crimes; and
21	"(C) developed a standardized system of
22	collecting, analyzing, and reporting hate crimes
23	to the National Incident-Based Reporting Sys-
24	tem of the Federal Bureau of Investigation; or
25	"(2) may—

1	"(A) establish a unit or liaison specialized
2	in identifying, investigating, and reporting hate
3	crimes and engaging in community relations
4	functions related to preventing hate crimes; or
5	"(B) conduct an ongoing and regular pub-
6	lic meetings or educational forums on the im-
7	pact of hate crimes, services available to victims
8	of hate crimes, and any relevant Federal, State,
9	or local laws related to hate crimes.
10	"(n) Definitions.—In this section:
11	"(1) COVERED JURISDICTION.—The term 'cov-
12	ered jurisdiction' means a unit of local government
13	that has a requested a grant under this subpart and
14	has a population of over 100,000 people.
15	"(2) Hate crime.—The term 'hate crime'
16	means—
17	"(A) an act described in section $1(b)(1)$ of
18	the Hate Crime Statistics Act ((34 U.S.C.
19	41305(1)(b)(1); and
20	"(B) an act in violation of sections 241,
21	245, 247, or 249 of title 18, United States
22	Code.".
