3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Probationary Reduc-
- 5 tion for Employee Protections Act" or the "PREP Act".

1 SEC. 2. PROBATIONARY PERIOD REDUCTION.

2 (a) COMPETITIVE SERVICE.—Section 3321 of title 5,
3 United States Code, is amended by adding at the end the
4 following new subsection:

5 "(d) A probationary period under subsection (a) may6 not exceed—

7 "(1) 6 months for an initial appointment of an
8 individual who, immediately prior to such appoint9 ment, held a position in the civil service in the exec10 utive branch; or

"(2) 12 months for an initial appointment of an
individual other than an individual described in
paragraph (1).".

14 (b) EXCEPTED SERVICE.—

(1) IN GENERAL.—Subchapter I of chapter 33
of title 5, United States Code, is amended by adding
at the end the following new section:

18 "§ 3330g. Excepted service probationary period

"Except as otherwise specifically provided by statute,
the probationary or trial period before an initial appointment of an individual to a position in the excepted service
becomes final may not exceed—

"(1) 6 months for an initial appointment of an
individual who, immediately prior to such appointment, held a position in the civil service in the executive branch; or

1 "(2) 12 months for an initial appointment of an 2 individual other than an individual described in 3 paragraph (1).". 4 (2) CLERICAL AMENDMENT.—The table of sec-5 tions for chapter 33 of title 5, United States Code, 6 is amended by inserting after the item relating the 7 section 3330f the following new item: "3330g. Excepted service probationary period.". 8 (c) SENIOR EXECUTIVE SERVICE.—Section 3393(d) 9 of title 5, United States Code, is amended by striking "has served" and all that follows and inserting the following: 10 11 "has served— "(1) 6 months, if such individual held a posi-12 13 tion in the civil service in the executive branch im-14 mediately prior to such appointment; or 15 "(2) 12 months in all other cases.". 16 (d) INTERNAL REVENUE SERVICE.—Section 9510 of title 5, United States Code, is amended— 17 18 (1) by striking subsection (d); and 19 (2) by redesignating subsection (e) as sub-20 section (d).
