A BILL

To require the Director of the Centers for Disease Control and Prevention to create a standardized method for State, Tribal, and local health departments to report to the Centers with respect to COVID–19, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “COVID–19 Data
5 Transparency Act”.

1 **SEC. 2. STANDARDIZED METHOD FOR HEALTH DEPART-**
2 **MENT REPORTING .**

3 (a) IN GENERAL.—Not later than 30 days after the
4 date of enactment of this Act, the Director of the Centers
5 for Disease Control and Prevention shall create a stand-
6 ardized method for State, Tribal, and local health depart-
7 ments to report to the Centers with respect to COVID-
8 19 the following:

9 (1) Daily hospitalizations of patients in the re-
10 spective jurisdiction with a confirmed or presumed
11 case of COVID-19.

12 (2) Daily numbers of such patients in the inten-
13 sive care unit.

14 (3) Daily numbers of such patients on ventila-
15 tors.

16 (4) How long such patients have been in the
17 hospital.

18 (5) Daily numbers of diagnostic and serological
19 tests administered for SARS-CoV-2 with respect to
20 patients in the respective jurisdiction, disaggregated
21 by—

22 (A) the type of test; and

23 (B) the testing positivity rate of each type
24 of test.

25 (6) The sensitivity and specificity of each such
26 type of test.

1 (7) Daily numbers and percentages of contacts
2 traced with respect to patients in the respective ju-
3 risdiction.

4 (8) The rate of transmission of SARS-CoV-2
5 in the respective jurisdiction.

6 (b) POSTING BY CDC.—The Director of the Centers
7 for Disease Control and Prevention shall—

8 (1) post the information described in para-
9 graphs (1) through (8) of subsection (a), to the ex-
10 tent such information is in the possession of the
11 Centers, on the public website of the Centers, except
12 that such posting shall exclude any individually iden-
13 tifiable information; and

14 (2) to the extent feasible disaggregate such in-
15 formation by State, Tribal, and local jurisdiction.

16 (c) UPDATES.—The Director of the Centers for Dis-
17 ease Control and Prevention—

18 (1) shall, as appropriate, periodically update the
19 method posted under subsection (a); and

20 (2) may revise and expand the reporting cat-
21 egories listed in such subsection.
